#### 3.1 Rights to terminate the process

- **b.**This tender does not constitute an offer by BPFTIO. The Bidders' participation in this process may result in engaging the Bidder towards execution of the Contract.
- **c.** Any document, information, data or statement submitted by the Bidder in its Proposals, basing on which the selected Bidder will be considered eligible.

#### 3.2 Authentication of Proposals

The Proposal should be authorized by the authorized signatory of the company. The Proposal shall be sent by Registered Post/Speed Post/Courier only. It is desirable but not mandatory that companies send their one representative during the opening of the bids.

#### 3.3 Evaluation Process

- **a.** The BPFTIO reserves the right to reject any or all Proposals on the basis of any deviations.

#### 3.4 Proposal Validity

#### 5.1 Technical Evaluation

#### **5.2** Financial Evaluation

The Bidder shall be selected on the basis of Least Cost Selection (LCS)/L1.
